The corrections to the AmeriHealth 65 NJ HMO ANOC/EOC are found in the paragraph and chart below. The ANOC/EOC contained incorrect benefit information on page 70, page 71, and pages 71-72. The word “covered” was omitted from the Hearing Services, Vision Care and Health and Wellness Education Programs benefits listed in Chapter 4.

This notice serves as an amendment to your AmeriHealth 65 NJ HMO ANOC/EOC and replaces the applicable sections noted in the chart below. Please keep this updated information with your current AmeriHealth 65 NJ HMO ANOC/EOC materials for future reference.
